Preparing for HIQA Inspection

This 1 day workshop will give staff an overview of the role of HIQA (Health Information and Quality Authority) and will take you through the process of inspection in line with The Health Act 2007, Statutory Instruments, Regulations and the National Standards for your designated area.

Safe Administration of Medication (SAM)

This 2 day course will provide staff with the knowledge, skills and competencies to safely oversee the process of safe administration of medication to clients in their homes in line with best evidence-based practice guidelines. 1 day refresher also available.

PEG Training

This practical 1 day course will give you an understanding into your role and responsibilities for caring for an individual with a gastrostomy tube.

Oxygen and Nebuliser Training

This 1 day course will provide your staff with the knowledge to safely and effectively deliver a therapeutic dose of medication via a nebuliser/oxygen cylinder/oxygen compressor/inhaler to a client with Chronic Obstructive Pulmonary Disease.

Diabetes Training

This 1 day course will provide your staff with an overview of Type 1 and 2 Diabetes focussing on lifestyle management, diet, physical exercise and measuring blood glucose. Actions to take in an emergency will also be included.

Clinical Observations

This 1 day course will provide your staff with the skills to undertake measurement of Temperature, Pulse, Blood Pressure, Respiration, Urinalysis, SpO2 and Peak Flow reading.

Record Keeping

This ½ day workshop will give staff an overview of the importance of good record keeping and communication including the elements of person centred care and care planning, an essential tool for every healthcare professional.

Delegation Skills

This 1 day workshop will provide your staff with the skills required to delegate effectively and safely based on a recognised team skills matrix.

Crisis Intervention – Lone Worker

This 1-day course will provide your staff with the skills and competencies to recognise the early signs of disruptive behaviour and learn techniques to resolve a situation before it escalates. The course will also include the action to take in emergency situations.

Bereavement Training

This ½ day workshop will help your staff to recognise and deal with their own grief and cope with the immediate situation following the death of a service user.

Dementia Care Training

This 1 day course will provide your staff with an overview of dementia and the strategies and skills required to promote person-centred care and improve quality of life for clients and their family/relatives/carers with dementia.

Non Violent Personal Safety and De-Escalation Training

This 1 day workshop teaches employees early intervention and non-physical methods for preventing or managing challenging behaviour.

Governance Arrangements

This training will provide you with an opportunity to develop your Governance Arrangement in line with HIQA Standards and Regulations. The training will include arrangements for safeguarding, service users views, complaints, personal and intimate care, financial arrangements, recruitment, reporting arrangements for staff, supervision for staff and service level agreements.
